Construction Products/ Materials Certification Scheme

It is stipulated in Lembaga Pembangunan Industri Pembinaan Malaysia Act 520 (Amendment 2011) only building materials which have received the Standard Compliance Declaration (Perakuan Pemuatan Standard or PPS) can be used in construction projects (Schedule 4 of the Act). The main technical document required for consideration of PPS is the Product Certification (PC) or Full Type Test Report (FTTR) issued any accredited certification bodies and testing laboratories respectively.

CIDBH Product Certification is recognised to certify various construction materials/products to fulfil CIDB requirements namely ceramic tiles, sanitary wares, glass for construction, radiant barrier and iron & steel including deformed bar, wire rod, steel beam, scaffoldings, wire mesh, wire rope etc. We also able to certify water supplies product such as taps & mixers, flush valve and fittings mechanism as per SPAN regulatory requirements.

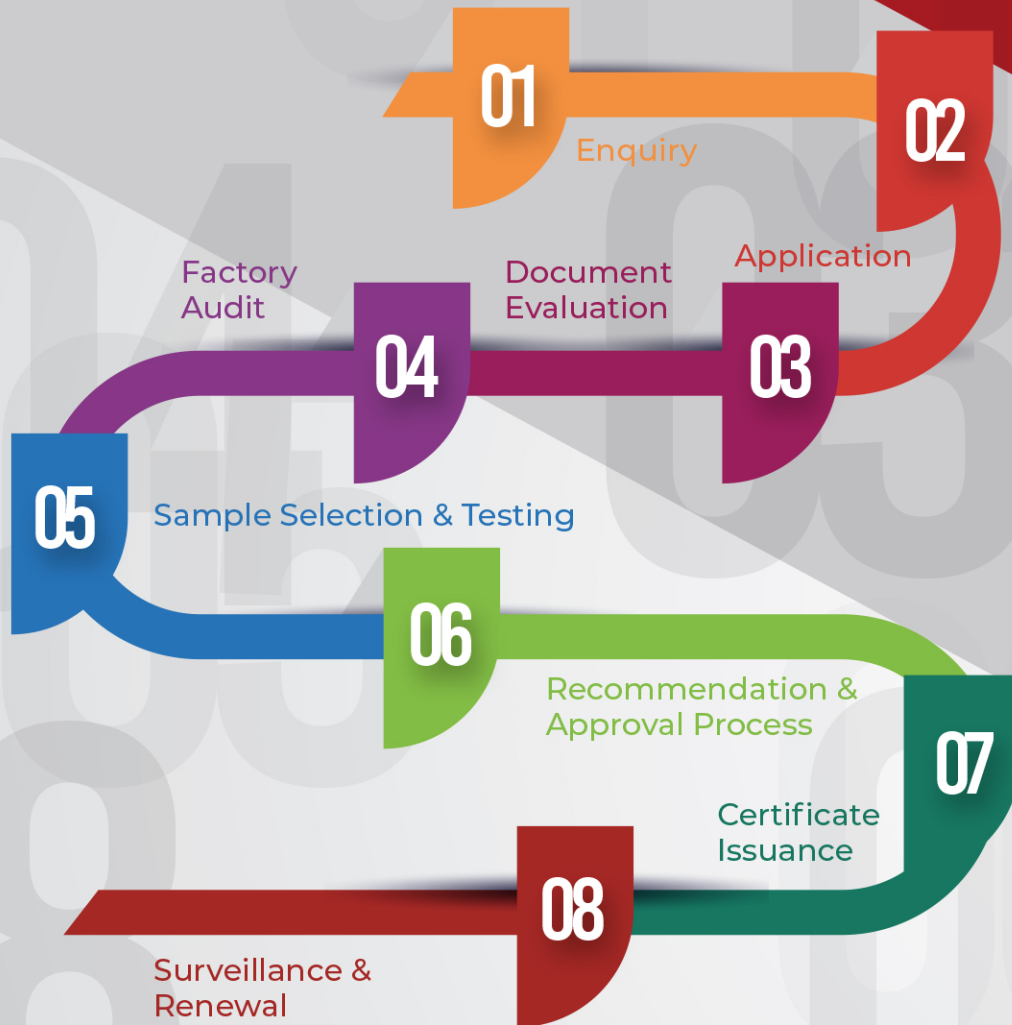
